## Belmont Stakes Ticketing and Admissions Policy

## **IMPORTANT NOTICES**

The ticket purchaser/holder ("Holder") must abide by the rules and regulations of The New York Racing Association, Inc. (NYRA). This ticket is a revocable license to enter Belmont Park on the event date listed on the front of the ticket. NYRA reserves the right to deny admission to, or remove from its property, any person not in compliance with the rules and regulations, acting in a disorderly manner, or causing a nuisance. Expulsion forfeits this ticket, without the refund of any portion of this ticket purchase price, and the Holder shall not have any claims against NYRA. Purchase of this ticket does not entitle the Holder to the same or comparable seat location for future events.

The Holder voluntarily assumes all risk of property loss, including property damage, vandalism, theft or destruction of property during the event for which the ticket is issued. Risk of loss or theft of tickets shall pass to the Holder; NYRA will not be obliged to admit the Holder unless ticket is presented.

The Holder, by presenting this ticket for admission, consents to the use of the Holders voice, image and/or likeness in any live or recorded video program, photograph or other transmission or reproduction of, or at the event or any surrounding activities for any and all purposes without further authorization or compensation.

Prohibited items include, but are not limited to, Alcoholic Beverages, Drugs, Weapons, Backpacks, Coolers, and Glass Containers. NYRA reserves the right to inspect all bags, boxes, or other containers and to refuse admission to any Holder for failure to comply with the inspection requirements and/or any Holder who possesses such items at the time of entry. Tickets obtained from unauthorized sources may be invalid, lost, stolen or counterfeit and if so, are void. Unlawful sale or attempted sale is prohibited. This ticket may not be resold within one thousand five hundred feet from the physical structure of this place of entertainment under penalty of law. NYRA reserves the right to deny admission to, or remove from its property, any person not in compliance with the aforementioned health and safety policies and protocols.

The Holder acknowledges and understands that, if infected with COVID-19 or other Communicable Disease (as defined below), the Holder and/or any Accompanying Party may infect others that they may subsequently come in contact with, even if they are not experiencing or displaying any symptoms of illness, and that the risk of exposure to others remains at all times.

A "Communicable Disease" as used herein is COVID-19, any strains, variants, or mutations thereof, the coronavirus that causes COVID-19, and/or any other communicable and/or infectious diseases, viruses, bacteria or illnesses or the causes thereof.

The Holder, on their behalf and on behalf of any Accompanying Party, acknowledges and expressly assumes all risks that are in any way related to or arising from being exposed to or contracting COVID-19 or other Communicable Disease at Belmont Park. By using this ticket, the Holder is acknowledging and confirming, both now and in the future, that the Holder understands and expressly assumes the risk that the Holder and any Accompanying Party may be exposed to COVID-19 or other Communicable Disease. The Holder expressly understands that these risks include contracting COVID-19 or other Communicable Disease and the associated dangers, medical complications and physical and mental injuries, both foreseen and unforeseen, that may result from contracting COVID-19 or other Communicable Disease. The Holder further acknowledges and understands that any interaction with the general public poses an elevated, inherent risk of being exposed to and contracting Communicable Disease, including, but not limited to, COVID-19, that it cannot be guaranteed that Holder or any Accompanying Party will not be exposed, and that as such, potential exposure to or contraction of COVID-19 or other Communicable Disease are risks inherent in the Holder's decision to use this ticket that cannot be eliminated.

## LIVE RACING CANCELLATION POLICY

The date and time of any racing event is subject to change based on, among other things, force majeure events (including, without limitation, acts of God and other unforeseen circumstances or causes beyond reasonable control). No refunds will be permitted based on such scheduling changes.

In the event that racing is cancelled at any time prior to park opening, or is taking place at Belmont Park without permitted patronage to the general public, and NYRA does not intend to reschedule such racing events, NYRA will issue ticket credits or refunds solely for all tickets/pre-paid parking purchased directly through the NYRA Box Office, or a NYRA Sales Representative, for the specific event days that are affected by such situation. In such cases, tickets purchased via third-party vendors are not eligible for a refund from NYRA and customers must directly contact the third-party vendors for assistance.

In the event that the park is opened as planned and racing is cancelled, for any reason, before five (5) races have been run, customers in any hospitality/dining venues with pre-paid buffets will be entitled to finish their selected menu and standard 4-hour beverage package only and NYRA will refund such Group for any additional hours purchased beyond the standard 4-hour beverage package. Except as set forth in the previous sentence, NYRA shall have no obligation nor have any liability to such Group. For all other customers, NYRA will issue ticket credits or refunds solely for all tickets/pre-paid parking purchased directly through the NYRA Box Office, or a NYRA Sales Representative, for the specific event days that are affected by such situation. In such cases, tickets purchased via third-party vendors are not eligible for a refund from NYRA and customers must directly contact the third-party vendors for assistance.

If racing is cancelled, for any reason, after five (5) races have been run, there are no refunds or exchanges of any kind.

NYRA reserves the right to modify your seat location(s) to adhere to potential social distancing guidelines if mandated that Belmont Park operate at a further reduced capacity level or that patrons must be significantly spaced apart, per New York State guidelines. We will provide additional information in the future should this scenario take place. Tickets may be subject to additional fees based on updated COVID-19 health and safety protocols.
